

At the outset the Registrar extended a warm welcome to the Chancellor to preside over the meeting. The Vice-Chancellor again welcomed the members and expressed condolence on account of sudden demise of Prof.(Mrs.) Santilata Mishra, Ex-Head, Post Graduate Deptt. of Mathematics and Prof. Dr. L.B. Parida, the ex-Head Post Graduate Deptt. of Zoology, Vani Vihar and former members of the Academic Council who died on 15.0.02 and 3.12.02 respectively. On the request of the Vice-Chancellor all the members observed two minutes silence as a mark reverence to the departed souls.

In the course of his introductory speech, the honourable Vice-Chancellor expressed concern on the important challenges in the system of the higher education. He threw some lights on the dilemmas faced by the system. The focal point of first dilemma is dualism i.e. qualitative and quantitative aspects of the education. The problem is that the quality of the education be maintained and quantity must not be ignored and neglected. The second problem is how to meet the emerging trend of liberalisation, privatisation, and Globalisation in the present context. Privatisation should not be discouraged. It should be regulated with conscious planning. Liberalisation and Globalisation should be pursued and continued. Adjustment of above trends is no doubt difficult but not impossible. Education is controlled by the economic forces. Fund is essential to impart qualitative education without neglecting quantitative aspect. The State does not have the necessary resources to finance. On the other hand it would not be possible to get much revenue by pursuing so called traditional education. Some traditional courses are out-dated in term of getting jobs. It should be re-modelled and professionalised. Laboratory and modern infrastructure are essential. Education should be pushed to a sort of category in which it would not depend much on state funding. It would depend on user fees people would pay for it. So privatisation is inescapable conclusion. But it should be regulate in a proper manner and should be responsive to the user fees. The Vice-Chancellor requested to the council to formulate planning and designing of new courses. So that it would able to solve the day to day problems of higher education.
