- 1. The need for introduction of meaningful, need based, career oriented and professional courses to meet the challenges of globalization and to ensure employment of the students.
- 2. The need for both quantitative and qualitative improvement in the Ph. D programme of the University and he highlighted that the UGC and Ministry of HRD has been emphasizing on the need for 5 fold increase under Ph.D. Programme.
- 3. The need to fill up of the vacant teaching posts for improvement of teaching learning ambience of the University.
- 4. The need for upgrading at least one state University to the status of excellence. He emphasized that Utkal University deserves to be upgraded to a Central University and Utkal University is striving towards attending the excellence status.
