1.1 Add

The Post Graduate Department/ Centre of Research may hold interview for exempted category of Research applicant to facilitate allotment of Ph.D. seats and may take into consideration areas of interest of the faculty and availability of facilities in the center for accepting such Ph.D. students; such interview of exempted category is not to fix the eligibility of the candidates but for allotment of Ph.D. programme seats in the P.G. Dept / Centre of Research.

3.1.4. The clause 3.1.4 be replaced with the following :

Existing Research Supervisor may accept fresh candidates and the SRC shall verify the eligibility of new Research Supervisors.

5. The Clause 5 be replaced with the following :

5.1 Ph.D. in Medicine and Dental discipline : the eligibility of the scholar and supervisor shall be determined as per norms laid down in the statutes and guideline of Medical Council of India/ Dental Council of India, if any.

5.2 Ph.D. in Technology : the eligibility of the scholar and supervisor shall be determined as per norms laid down in the statutes and guideline of All India Council for Technical Education.

Item.No.22 Considered the ratification of the action taken by the Vice Chancellor in approving the following arising out of proceedings of the Internal Quality Assurance Cell, One day workshop on Choice Based Credit System under Semester and Workshop on NAAC reaccreditation

1. Resolved that the proposed Model P.G. regulation be applicable to the P.G. Departments of the University, Law Colleges and DDCE. Further resolved that the Chairman , P.G. Council, the Principals of Constituent Law Colleges and the Director DDCE may implement the new regulation under approval of the Vice Chancellor with suitable modifications.
2. Resolved that the proposed reform in Board of Studies and Management of examination as follows be approved.

- The Teacher Council of the P.G. Dept., to act as the Board of Studies for all courses offered by the P.G. Dept. and they may invite external members as per requirement subject to approval of the Vice Chancellor.
- The teachers Council of DDCE and Heads of P.G. Depts. (for subjects offered by DDCE) shall act as the Board of Studies for courses offered by DDCE and DDCE may invite external members as per requirement subject to approval of the Vice Chancellor.
- The Teacher councils of P.G. Dept. of Law, M.S Law college and University Law college shall act as the Board of Studies for courses offered by the constituent Law colleges and the Principals may invite external members with mutual consultation subject to approval of the Vice Chancellor.
- The existing Board of Studies will act as the Board of Studies for courses offered under affiliated colleges.
- Like Autonomous Colleges, P.G. Depts. (including SFS Courses), M.S. Law College, University Law College and DDCE would process the examination results with the approval of Controller of Examinations, Conducting Boards and the Vice Chancellor and forward copies of T.R. to the University for Preparation of original Degree. (Recommendation of IQAC)

- Considered and approved the proposed reform regarding regd. number as follows:
The Examination Roll No. shall be treated as the University Regd. No. (Exam). and Migration shall be issued across a counter on production of Admit Card or Surrender of Regd. No. in case it has been issued. Regd. Fees Rs. 60/- + Recognition fees Rs. 10/- shall be collected along with examination fee, when a student register for the first examination s/he takes up under the University and for subsequent examinations, Regd. Fees @ 50% i.e. Rs. 30/- shall be collected. (This is as per provisions of Statute)
- Considered the summary of Proceedings of Internal Quality Assurance Cell meeting held on 04.07.2011 and 25.02. 2011 and the report of the one day workshop on NAAC reaccreditation held on 06.08.2011 and resolved that this be noted and the University administration may act upon the proceedings."
- Considered authorizing the Vice Chancellor to explore the institution of following courses under the constituent P.G. Departments of the University:
 - Master of Business Administration in Retail Management
 - MBA in Financial Analysis and Risk Management.
 - Integrated M.Tech in Food Technology. And
- Resolved that under the existing provisions of the Act and Statute the Vice Chancellor is empowered for the above and as such there is no need for the Academic Council to specifically authorize the Vice Chancellor.

- Further resolved that MBA in Financial Analysis and Risk Management may be instituted in the P.G. Dept. of Commerce in collaboration with the P.G. Dept. of Business Administration and this course may not to be introduced under affiliation.
 - Further resolved that the Professor in charge of Research and Development may prepare detailed project report for instituting Master in Business Administration in Retail Management, Integrated M.Tech in Food Technology and such other course in frontier areas for consideration of appropriate authority of the University.
24. Considered the change of nomenclature of the following degrees: Bachelor Degree in Prosthetics and Orthotics to B.Sc. in Prosthetics and Orthotics and resolved that as the above two degrees do not figure in the approved list of degrees and diplomas of UGC the nomenclature of the degrees be changed to B.Sc in Prosthetics and Orthotics.
- Further resolved that the UGC be moved for inclusion of the nomenclature of Bachelor degree in Prosthetics and Orthotics in its approved list.
 - Further resolved that the Rehabilitation Council of India may be moved for taking up the matter with the UGC for inclusion of such nomenclature by the UGC.
 - Further resolved that the Bachelor degree in Prosthetic and Orthotics be considered equivalent to B.Sc. in Prosthetics and Orthotics and the Vice-versa.
25. To consider the recommendation of the Board of Studies of Geography (held on 17.08.2011) for approving the revised M.A. M.Sc. Geography Syllabus, 2011-12 onwards and resolved that the recommendations be approved.
26. To consider the following recommendations of the Board of Studies of Business Administration (held on 23.03.2010):
- The revised syllabus and regulation for all the MBA programmes run in the department of Business Administration, Utkal University is approved (namely: MBA (F.T)-2yr, Exe. MBA(3yr), Integrated MBA (5yr) and 2yrs MBA (Agri-Business)) effective from the admission batch 2010 (Academic session 2010-11).
 - The duration of theory examination papers of BBA Examinations under Utkal University (for 70 marks paper) shall be 3 hours duration instead of 2 hours effective from examinations of 2011 and onwards.
- And resolved that the recommendations be approved.

Dr. G.C. Pradhan, Registrar, offered a vote of thanks to the Chair and others present. The Vice Chancellor, Chairman of the Academic Council adjourned the meeting to a date to be fixed and notified later.
